#### Recognition and help is here!

In February, I attended the first Elder Abuse Prevention Unit meeting for 2019. It was a well attended meeting with a large number of organisations represented.

The work carried out by various bodies was related to the meeting by their representatives and showed a diverse coverage of just what is being done for the lesser privileged in our communities.

Reports on Domestic Violence numbers impacted hard on those present. A report on the regularity of call-outs by Police Officers and the number they attend on every shift; Ethnicity and Domestic Violence (with many afraid of retaliation; fear of further abuse; don't want to "air" the dirty linen; some think it's part of life; the norm or they're shamed. They are frightened of payback.)

A report on the number of children held in custody at the time of the meeting over a period of 28 days was sixty. Their parents are not interested in them and their grand-parents can't handle them.

Discussion centred on the My Aged Care website and the difficulty in navigating same. We have since learned that an Aged Care System Navigator will be set up in Hervey Bay on a trial basis with Logan and Redlands being included in the scheme. Of course, it's no help to those who are not connected to the internet as they don't have computers with many not interested in making the step to connect.

There will be a large number of organisations making submissions to the Aged Care Royal Commission. The most talked subject among organisation representatives appears to be Residents/Staff ratios. Let us hope that this commission

will not be a waste of money and actions will be implemented in the correct areas of complaint.

The Aged Care Round Table discussion was hosted by the Queensland Nurses and Midwives Union and representatives from Aged Care stakeholder groups and community organisations.

Present were Aged Care Crisis; ADA Australia; Dementia Australia; The Ageing Revolution; Motor Neurone Disease Australia of Queensland (MND); the Australian Pensioners and Superannuants League and the Queensland Nurses and Midwives Union.

Meetings with representatives of the Brisbane City Council and on returning to Rockhampton, Nola met with the Benevolent Society's, Joel Pringle and President of National Seniors, Ian Henschke. (Page 8)

At their Rockhampton meeting, the trio discussed the contents of their organization's approaches which would be presented to sitting members and candidates for pre-budget consideration. All organisations are pushing for increased pension payments and our organisation is supporting the Benevolent Society's proposal to introduce a Pension Tribunal as are the National Seniors.

From the APSL 2018 State Conference - Members are calling for a tribunal and support the Benevolent Society in their push. Regional branches agreed to take the fight also to their elected representatives in a clear sense of "Shape up or ship out"!

When addressing conference Joel Pringle went on to say "that the current Age Pension is leaving many people behind; without adequate food, housing, heating, medical supplies, dentistry and other life essentials.


This was confirmed in the Adequacy of the Age Pension in Australia report, a joint release by the Benevolent Society, the Longevity Innovation Hub and Per Capita."





Joyce is also Area Two Organiser and visits the branches within that zone and in particular, Collinsville.


Joyce is a member of the APSL Management Committee and attends meetings in Brisbane. She regularly visits branches and passes on what the APSL is all about and what we are doing.

## Australian Pensioners and Superannuants League's State Secretary, Nola Harvey met with National Seniors Ian Henschke and Benevolent Society's, Joel Pringle in Rockhampton on Wednesday, February 6.



#### By Chief Advocate Ian Henschke

This week I've been busy on the road with Joel Pringle, campaign organiser with our partner the Benevolent Society.

We've been in the federal electorate of Capricornia in Central Queensland promoting the Fix Pension Poverty campaign.

We spoke to the local Federal Member Michelle Landry and National Seniors

members in Rockhampton, as well as addressing the Rotary Club in Yeppoon. We also talked to the Pensioners and Superannuants League of Queensland.

Local radio and print media provided good coverage and I will be following this regional visit up by going to Canberra next week and targeting the crossbench senators.

If you want to help push the campaign along, please visit our website.

- \* Essentially, what we're fighting for is:
- \* Establishment of an Independent Age Pension Tribunal to take the politics out of the Age Pension
- \* An increase in the maximum rate of Commonwealth Rent Assistance, because the older Australians who are worst off are those who don't own their own home and must rent
- \* A subsidy for pensioners to connect to the NBN or another appropriate internet service because governments and business are increasingly only offering essential services and information online.

We'd also like to see an expansion of basic dental care for pensioners, given the high rates of poor dental health among older people.

Another big issue that arose in the past week was concern over the closure of three Service SA centres in Adelaide.

Once again older Australians, many of whom can't afford computers and internet services, are being told to get online for essential information.

I was asked to speak at a major rally at Parliament House in Adelaide and show National Seniors support for keeping the centres open by signing a petition to go before the SA Parliament.

## This is a copy of the contents of letter sent the Hon Joshua Frydenberg, Federal Treasurer and other Federal Parliamentarians

"At the 2018 State Conference of the Australian Pensioners' and Superannuants' League Qld Inc., Mr. Joel Pringle, Advocacy Campaign, Benevolent Society, was one of guest speakers. Following his address to the delegates in attendance at this conference, it was decided to prepare the following agenda item:

This State Conference calls on the Federal Government to create an individual tribunal to set the base rate of the age pension to fix pension poverty in Australia.

#### Supporting statement:

As we heard from Joel Pringle from the Benevolent Society, that many people past retirement age are experiencing and living in poverty. The Australian Pensioners' and Superannuants' League Qld Inc., would like the Federal Treasurer to take appropriate action to form a tribunal to fix pension poverty.

We are all aware that the current aged pension is leaving people in many instances unable to maintain a healthy well- balanced lifestyle. Many pensioners are:-

- \* Having an inadequate nutritious food intake on a daily basis.
- \* Not cooking so they do not use electricity or gas because of the cost involved.
- \* Turning off Hot Water Systems in summer to prevent paying escalating costs of energy.
- \* Not using heating in winter and cooling during summer especially during extreme temperatures, also because of the cost.
- \* Resorting to attend food banks to access food, if these are available in the vicinity of place of residency.
- \* Being non-compliant with their medication especially regarding frequency as directed by their treating Doctor in order to make their medications last longer.
- \* Often reaching the situation of having to make the choice between food and medication as they cannot afford both.
- \* Suffering a chronic illness, are struggling to pay their monthly accounts to maintain equipment or purchase other necessities for the ongoing treatment of their illness.
- Not attending regular Dental checks and often going to the extreme of blending or mashing food to avoid seeing a Dentist as it is too expensive to visit one.
- Unable to fund repairs or replace their larger electrical appliances such as washing machine or refrigerator, often calling on family for financial assistance to attend to this and others who don't have family assistance, resorting to charities like St. Vincent de Paul, Life line or the Salvos.
- Struggling financially to maintain their Private Health Insurance which is seen to be a high priority to allow them to have medical treatment at a hospital/medical centre of their choice.
- Cancelling their Private Health Insurance because of increasing cost of that insurance, thus placing pressure on an already stressed Public Hospital System.
- Paying rent and claim this to be their biggest expense, although they can access Rent Assistance, pensioners still struggle with this. It has been stated many times that housing costs are increasing faster than the pension.

- \* Single home owners struggle to attend to general maintenance on their home.
- \* Home owners are now just paying Contents insurance because of escalating Home Insurance payments.
- \* Car owners are finding it economically frustrating to cope with Registration. Insurance and other running costs and therefore having a vehicle is becoming quite a burden. In the larger cities, some have the option to forego having a vehicle because of the very efficient public transport system. Those who live in rural areas do not have this option.
- \* Many older pensioners worry about when they may require admission to an Aged Care Facility, that they may be unable to fund their admission for a number of reasons. Some of these being:-
  - They haven't had the opportunity to accumulate a substantial Superannuation.
- Unable to add to their savings while on the Aged Pension or have had to dip into their savings to pay for other necessities.
- Because of the current economic climate especially the decline in Real Estate values adds to the distress of having insufficient funds for their admission.

The Aged Pension is increased twice a year which is generally intended to offset rising costs. The fact is that these increases are automatically followed by increasing costs and often these pension increases do not correspond with the increased costs.
